Declarations, Consents

in relation to WIZZ Youth Challenge (WYC)

Who controls your personal data? The data controller is Wizz Air Hungary Ltd. (Kőér street 2/A, Building B, Floor II-V, 1103, Budapest, Hungary)

For what purpose, on what legal basis and for what period will your personal data be processed? The purpose of, the legal basis for, and the period of personal data processing are summarised in the following table.

What rights do you have? Pursuant to Regulation (EU) 2016/679 of the European Parliament and the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), you

- (i) have the right to request access to personal data relating to you, requesting information on the data processing by Wizz Air Hungary Ltd. Provision of information or of copies of the processed data is free of charge. If you request additional copies, you may be charged a fee of reasonable extent, based on the administrative cost,
- (ii) have the right to request the rectification or the deletion of personal data relating to you or the restriction of its processing,
- (iv) you may request from Wizz Air Hungary Ltd. information on the recipients who have been informed of the rectification or erasure of the personal data or the restriction of its processing,
- (iv) if the legal basis for the data processing is your consent, then you have the right to withdraw your consent at any time, although the withdrawal of consent shall not affect the lawfulness of data processing based on the consent prior to its withdrawal. After the consent has been withdrawn, Wizz Air Hungary Ltd. is still entitled to process personal data in order to fulfill its legal obligations or to enforce its legitimate interests, provided that the enforcement of the interest is commensurate with the restriction on the right to personal data protection,
- (v) if the legal basis for the data processing is your consent or the performance of the contract, then you may exercise your right to data portability: in respect of any personal

data relating to you, that you have made available to Wizz Air Hungary Ltd. and which is automatically processed, you may request that such data be delivered to you in a structured, extensively used and machine-readable format, or to transfer this data to another data controller. You may also request – if it is technically feasible – that your personal data be transferred directly by Wizz Air Hungary Ltd. to another data controller.

Who are the recipients of your personal data?

Personal data provided will not be transferred to any third parties besides the Organizer members of the Jury, business partners of Wizz Air acting for the above purposes (including PR agencies) and members of the media.

What options are available to you for legal recourse?

Regarding the lawfulness of data processing, you can initiate a procedure with the National Authority for Data Protection and Freedom of Information (1125 Budapest, Szilágyi Erzsébet fasor 22/c., postal address: 1530 Budapest, Pf.: 5, website: www.naih.hu, tel.: +36 (1) 391-1400, fax: +36 (1) 391-1410, central e-mail address: ugyfelszolgalat@naih.hu) or you may take the matter to court. We recommend that you contact our data protection officer before turning to the National Authority for Data Protection and Freedom of Information or to a court of law.
